



A 10k and Half-Marathon in Texas Wine Country

About This Event: Both chip timed races start at 8:30 a.m. on Saturday, Dec 1st. Both events start and finish at Spicewood Vineyards and Winery in Spicewood, Texas off of Hwy 71 about 40 miles west of Austin and 90 miles north of San Antonio (1419 Burnet County Road 409; directions at spicewoodvineyards.com). The 10K and Half follow along a challenging out and back course along scenic farm roads in Burnet County. The course features 3 fully stocked water stops that will be hit twice (6 stops) each for the 1/2 Marathon and 2 water stops hit twice (4 stops) each for the 10K. Post-race festivities include wine tasting and food. All runners also receive a technical shirt and etched wine glass with race logo. Four-hour time limit for both events. **Awards:** Male and Female: Overall Open (Wine and Medal), Overall Master (Wine and Medal), 29 and under, 30-39, 40-49, 50-59, 60 and up. Wine and Medal to age group winners, medals to top 3.

Special Christmas Award for Santa Division (Male) and Elf Division (Female) for 1st in division and best costume. Wine and Medals. **JUDGING TO TAKE PLACE AFTER PRE RACE BRIEFING AND NATIONAL ANTHEM AT 8:15AM.**

HALF-MARATHON ENTRY FEES: \$70 through 11-1, \$80 through 11-17, \$90 after that and \$100 on race day.
